Tuition Fees

Tuition fees include the provision of tuition, careers counselling, pastoral care, use of library and sports equipment, use of the swimming pool, sporting facilities, kitchen, science laboratories and equipment, class sets, photocopied materials, curricular excursions etc. All tuition fees include the cost of Mathletics software which is available to all students from Prep to Year 12. Additional school requirements may include stationery, textbook hire, replacement identity cards and lost library/textbooks which are a parent's responsibility.

Levies

Annual General Levy

The Annual General Levy covers insurance and curriculum related excursions, curriculum bus travel, padlock hire*, the Recorder magazine, ID card*, school diary* and other incidentals. *A replacement charge will apply for lost padlocks, ID cards and school diaries. Technology Levy

The Technology Levy covers the costs associated with the use of technology within the School curriculum, including the school laptop program. A laptop computer (or similar) will be provided to every student in Prep - Year 12 (in our One Laptop per Student policy) – refer to the Laptop Charter for details. A replacement charge will be levied for any lost or damaged devices.

Infrastructure Levy

To assist with the capital program of the School, an Infrastructure Levy will be applied to each student from Prep to Year 12. This levy is charged per term.

Anglican Schools Commission (ASC) Levy

The ASC has established a nominal levy applicable to students in Anglican Schools within the Brisbane Diocese. This levy will assist the Diocese with their Anglican Ministry.

NAPLAN Levy

Students in Year 3, 5, 7 and 9 will be charged an annual levy of \$25 in Term One as charged by the State Government.

All levies are due for payment in Term One except for the infrastructure levy which is charged per term.

Other Fees and Charges

Year Camps/Conference Fees (Compulsory)

Year Camps/Conferences are compulsory for Years 1-11. Fees range from \$200 to \$1,300 and will be applied to the fee statement for the term in which the camp or conference takes place.

Foundation Building Fund Donation

This voluntary contribution is tax deductible and the amount is a suggestion only. Any donation will be gratefully received. The suggested contribution is \$175 per term or \$700 per year per student. All families are encouraged to participate.

Additional Voluntary Charges

Music Tuition is by private arrangement between instructor and parents through the Music Department.

Music Instrument Hire	\$100 (one semester only) or \$160 (entire year)
Star Tutoring	\$55 per private lesson
Extra-Curricular Sport and Activities	Levies are charged by the P&F association Support Groups to support some extra-curricular activities. These are separate to the School and are charged directly by the P&F. They may range from NIL to more than \$100 dependant on the activity, but the majority are approximately \$30-60 per activity.

Concessions

All discounts are only applicable to tuition fees. Where there are two or more students from the one family attending St Aidan's at the same time, the following discount will apply to the younger students.

Sibling discount - second child	6%
Sibling discount - third child	10%
Sibling discount - fourth child	10%
Annual discount	3% discount on tuition fees if the annual account including levies is paid in full by the first day of Term 1.
Multiyear Discount	Future year tuition at current year rates if paid in full by the first day of Term 1 in current year. Does not include levies or other charges.

Payment Methods

Fee statements are issued by email to the billing address and are payable by the first day of each term or annually.

- Bpay
- MasterCard/Visa/AMEX in person or over the phone (all credit card payments subject to 1% surcharge)
- Edstart payment plan

Edstart Payment Plan

Edstart allows you to pay your school fees in weekly, fortnightly, or monthly instalments. You can spread your fees evenly across the school year, as well as reduce your repayment amount by extending the cost over a longer time frame. For more information visit edstart.com.au/staidans

Payment Terms

It is the intention of the School Council to set fees once each year, however, the School reserves the right to revise fees at any time. The School charges fees per term (Year 12 students are billed across three terms) and issues termly Fee Statements.

Accounts must be paid in full on or before the first day of each Term.

The School cannot provide education to students where fees remain unpaid. It is an enforced policy of the School that a student may not take her/his place at the School at the start of a Term where fees for a previous Term remain unpaid.

Due Dates

Term 1: 25 January 2022

Term 2: 19 April 2022

Term 3: 12 July 2022

Term 4: 4 October 2022

An agreement to pay by instalments may be entered into through Edstart, visit edstart.com.au/staidans for further information including applicable surcharges.

Optional activities will not be available to students if parent accounts are not paid in full. Any funds paid towards these activities will be directed to parent accounts in this situation. Optional activities include exchange programs, overseas tours, co-curricular sporting camps/tours, and private music or speech and drama lessons.

Parents are reminded that any fee concessions received are dependent upon the fees being paid by the due date.

Concessions will be withdrawn if this condition is not met. Concessions include scholarships and bursaries.

Late Payment Fee

Fees are payable on the first day of each term. Late payments will attract a monthly surcharge of \$75.
